Refund Policy / Class Credit

- Each class has a three (3) day no-fault, no penalty withdrawal/drop period. Students may receive a full refund of all paid tuition fees, upon written request, for any drop/withdrawal prior to the first day of class or within the first three (3) days after the class starts.
- Withdrawals or drops after the no penalty period will be prorated for any period prior to the tenth (10) day of classwork. All withdrawals require prior written request / notification.

Terms and Conditions

1. In addition to fees listed above, the applicant is responsible for additional testing fees, resulting from test failure. The facility will provide up to five (5) hours of training at no cost to the applicant after the first failure.
2. Payment in full of program fees is due to the facility no later than the first day of training unless prior arrangements are made.
3. The Oral and Practical portion included in the A&P course lasts five (5) days. Any extended training is priced at \$57.37 per hour. Student is responsible for all extended costs.
4. The Eglin Aero Club makes no representation that credits earned at this facility can be transferred to another specific institution. Transfer of credits is wholly at the discretion of the accepting institution and it is the student's responsibility to confirm whether or not credits will be accepted at the institution of the student's choice.
